Receive Approved name and Company Registration number eg: (2015/123456/07)

B. NEW INCOME TAX REFERENCE NUMBER

2. Company (SARS) Income Tax Reference Number.
Issued automatically by CIPC.

B. NEW BANK ACCOUNT

3. Open the Business Bank Account in the name of the New Company.
Copy of Founding Statement.
Proof of Residence of Directors of the company.
Letter from accounting officer confirming proof of share percentage.

D. NEW TAX CLEARANCE CERTIFICATE

4. Tax Clearance Certificate (New Company)
